SCHOLARSHIP/GRANT TERMS AND CONDITIONS

ENTRANCE SCHOLARSHIP

1. I shall carry a load of not less than 18 units or the regular curricular load for my degree program
2. Should I, during the semester, drop any subject, change any subject or schedule or shift program without the prior approval of the Scholarship Committee, I shall be disqualified for scholarship for the succeeding semester
3. I shall comply with the required PE/NSTP subjects during the semester and get a passing grade or higher in NSTP

MERIT SCHOLARSHIP

1. I should have carried a load of 18 units or regular load of my degree program for the immediately preceding semester
2. I shall carry a load of not less than 18 units or the regular curricular load of my degree program for the current semester
3. That should I, during the semester, drop any subject, change any subject or schedule or shift another program without prior approval of the Scholarship Committee, I shall be disqualified for the scholarship for the succeeding semester.
4. I shall comply with the required PE/NSTP subjects during the semester and get a passing grade or higher in NSTP

JPL-SHL SCHOLARSHIP

1. I shall enroll in the program identified and approved by the Scholarship Committee
2. I shall carry the approved load as prescribed in the curriculum of my program, including the required PE/NSTP subjects during the semester
3. Should I, during the semester, drop any subject, change any subject or schedule or shift program without the prior approval of the Scholarship Committee, I shall be disqualified for scholarship for the succeeding semester.
4. Once disqualified, I understand that I cannot be reinstated to the same scholarship

DANCE TROUPE/CHORALE

1. I shall finish my program in LPU.
2. I will carry not less than 15 units load per semester.
3. Should I fail in one (1) subject, I will automatically forfeit my scholarship privilege.
4. I will strictly observe punctuality during practice sessions and performances.
5. Aside from academic deficiency, other grounds for losing my scholarship shall be any of the following:
 - a. Commission of any infraction ranging from serious to very serious offenses as defined in the Student Handbook during the previous semester.
 - b. Failure to attend practice sessions and actual performances.
6. Should I, during the semester, drop any subject, change my subject or schedule, shift to another program or stop from schooling without the prior approval of the LPU Scholarship Committee, I will be disqualified from the Scholarship program in the succeeding semester.

ATHLETIC GRANT

1. I shall finish my program in LPU.
2. I shall carry not less than twelve (12) units as my load each semester
3. I shall pass at least 60% of the total number of enrolled units as provided by the rules of the athletic leagues of LPU joins
4. I understand that should I fail to meet the requirements and eligibility rules of the league, I will automatically forfeit my scholarship privilege
5. I shall strictly observe attendance and punctuality during practice sessions and official games where LPU is participating
6. Should I, during the semester, drop any subject, change any subject or schedule or shift program without the prior approval of Athletics Department & the LPU Scholarship Committee, I will be disqualified for scholarship program for the succeeding semester
7. I understand that aside from the academic deficiency, other ground for losing my scholarship shall be any of the following.
8. Dropping from roster of varsity player
9. Unsportsmanlike conduct
10. Failure to meet requirement of practice and official games
11. Violation of school rules and regulations as stated in the Student Handbook
12. Joining National Team &/or other teams without clearance from the Athletics Director
13. For as long as I enjoy LPU's athletic scholarship benefits, I shall not transfer to another school. Violation of this prohibition shall subject me to the penalty of reimbursing LPU all tuition and miscellaneous discounts I had enjoyed

As a player, I shall not play in other leagues for the duration of the athletic leagues participated in by LPU unless approved in writing by the Athletics Director.

REGINA P. LAUREL SCHOLARSHIP

1. That I shall carry a load of not less than 18 units or the regular curricular load for my degree program;
2. That should I, during the semester, drop any subject, change any subject, or schedule, shift courses or stop from schooling without the prior approval of the Scholarship Committee, I shall be disqualified for scholarship in the succeeding semester;
3. That I shall comply with the required PE and NSTP subjects during the semester;
4. If needed I shall render part-time service of one hundred (100) hours per semester in LPU for the duration of my scholarship.

KANEGAE-IFUGAO SCHOLARSHIP

1. Should I fail any subject I enrolled, I can no longer renew my scholarship
2. I shall comply with the required PE/NSTP subjects during the semester
3. Should I, during the semester, drop any subject, change any subject or schedule or shift program without the prior approval of the Scholarship Committee, I shall be disqualified for scholarship for the succeeding semester
4. If needed, I shall render part-time service of one hundred (100) hours per semester in LPU for the duration of my scholarship

PROF. CONSOLACION SAUCO SCHOLARSHIP

1. I shall enroll in any baccalaureate program offered under the College of Arts of Sciences.
2. Should I, during the semester, drop any subject or change my subject or schedule, shift to another program or stop from schooling without the prior approval of the LPU Scholarship Committee, I will be disqualified from the Scholarship program for the succeeding semester.
3. I shall carry the approved load as prescribed in the curriculum of my program.

Additional Terms and Conditions for all Scholarships/Grants

1. Under the "no dual scholarship" policy of LPU, I shall not enjoy any other scholarship, within or outside LPU, except the scholarship granted to me by LPU.
2. I shall not commit any infraction ranging from serious to very serious offenses as defined in the Student Handbook.
3. In view of the changing economic environment that will affect enrolment, scholarship benefits for this semester may be adjusted.
